This position reports to the Rehabilitation Manager.

- Together with the marketing and fundraising manager grow and develop a marketing and fundraising plan
- Develop and manage an approved budget

Key competencies:

The successful candidate will be a team player who is physically fit, hard-working in all weather conditions frequently in excess of standard working hours. The position will be best suited to a dedicated, self-motivated individual who has a passion for seabirds and conservation, with a personable, caring and compassionate nature. The successful person must have excellent communication skills (verbal and written). A two month extensive training programme for the successful candidate will be provided at SANCCOB's facility in Cape Town.
